#### **CHANGES TO BY-LAWS:**

Discussion and review re: proposed changes to existing SCYF By-Laws. Vote to be conducted electronically via Survey Monkey or similar. Vote link will be provided TBD, but no later than March 27, 2020.

#### **Discussion:**

# Change proposed to add language to help insulate SCYF from potential issues related to "undue influence". Please see the attached cover letter and proposed language.

The purpose of this proposed amendment to our By-Laws is to further insulate and/or mitigate misperceptions pertaining to the Undue Influence (CIF By-Law 510\*) of players within the SCYF program. By requiring that SCYF's Board Members are independent\*\* from a high school football and/or cheer program, we enhance the protection against Undue Influence and reinforce the Board Member's singular focus on the development of the SCYF program and it's players/members.

This By-Law provision elevates protections of "recruiting" players at the high school level and is within the same spirit as OEC rule Article IIB8.i, which states "Recruiting, Soliciting, or Enticing participants, either directly or indirectly, from previously affiliated OEC Association Rosters is strictly prohibited and will subject any person found in violation of this prohibition to be suspended for a period of 12 months."

\*CIF Bylaw 510, "Undue Influence is any act, gesture, or communication (including accepting material or financial inducement to attend a CIF member school for the purposes of engaging in CIF competition regardless of the source) which is performed personally, or through another, which may be objectively seen as an inducement, or part of a process of inducing a student, or his or her

parent(s)/guardian(s)/caregiver, by or on behalf of, a member school, to enroll in, transfer to, or remain in, a particular school for athletic purposes."

\*\*Reference the proposed By-Law amendment for defined restricted roles relative to an association with a high school football and/or cheer program.

Discussion: Misc. adjustments to language in other provisions of the By-Laws.
